Dear Participants,

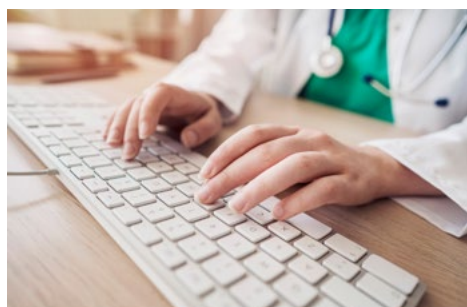

## ONLINE SUBMISSION PROCEDURE

After logging on <https://scientific.efort.org/efort2025> follow the onscreen instructions through the system to guarantee a correct and complete submission. A **valid email address** for each co-author is mandatory. EFORT will contact authors via the email addresses given during the submission process.

**Abstracts must correspond to previously unpublished work.** EFORT reserves the right to reject your abstract if previously presented. Moreover, EFORT has focus on ethical research misconduct. Any kind of plagiarism or fraud like fabrication and falsification of data will not be tolerated and handed over to the corresponding responsible authorities.

Submission is defined by differentiation of Clinical Research vs. Basic Science vs. Review studies and by one presentation type among Free Paper or Clinical Report (oral podium), or as Poster. EFORT reserves the right to change your abstract(s) allocation. There is no restriction on the number of submissions from a unique author or group, but each registered participant will have a maximum of six abstracts (3 oral presentations and 3 posters) accepted.

**Double submissions are automatically withdrawn.**

## INFORMATION ON ABSTRACT ACCEPTANCE

Authors and co-authors will receive acceptance/rejection notifications on **Wednesday 31 January 2025**.

The presenting author of a selected abstract must undertake to attend the Congress and present the abstract in the session and at the time designated by the EFORT Science Committee. **EFORT requires each presenting author to complete his/her full registration to the congress to validate his/her abstracts in the final scientific programme.** Deadline for registration of presenting authors is **Friday 28 February 2025, 23:59 CET**.

## ORAL PRESENTATIONS

Abstracts accepted as Free Papers are presented orally within scientific sessions embedded in the core Congress programme. Very high scientific quality is expected from these presentations, which should correspond to complete studies with outstanding results and innovative conclusions. To ensure that sessions run smoothly, please refer to the Presentation Guidelines available online. The best-rated Free Papers under both Orthopaedics and Trauma main categories will be selected to compete in the Free Paper Award competition and will receive specific guidelines.

## POSTER PRESENTATIONS

All abstracts accepted as Posters will be presented at the Congress as print wall paper posters. Authors are welcome to add images, tables and detailed data to better document their work. A large display area will be dedicated to poster presentations and Poster Walks will be organised during the Congress to have posters evaluated by experts in the corresponding fields. To ensure that posters are under the correct format for display, refer to the Poster Guidelines available online. Best-rated Posters will compete for the Jacques Duparc Award and will receive specific guidelines.

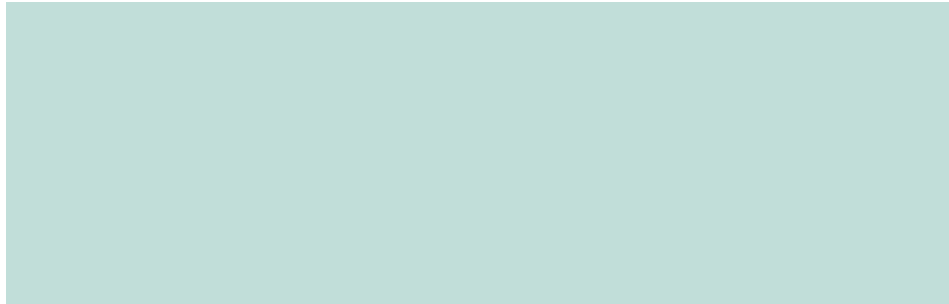

### HOW TO GET TO LYON

#### ■ By Air

**Lyon Saint Exupéry Airport** is France's 2<sup>nd</sup> regional airport: 116 direct destinations including 96 international destinations (36 countries) with 44 airlines.

First French airport in terms of client satisfaction in 2018. The welcome scheme in place for visitors attending association congresses and trade shows are all part of the **Welcome by Only Lyon** initiative.

Lyon Saint Exupéry airport is **directly connected to the TGV** and to the Lyon city centre every 15 minutes in under 30 minutes thanks to the **Rhone Express rail line**.

The airport is accessible through other various transportation options: **Taxi, Airport Shuttle Buses** or **car rentals**.

It is located close to the **A432 motorway**, connected to Lyon city centre by the **A43 (E711) motorway**.

#### ■ By Train

The second largest city in France is blessed with **great rail (SNCF)** and **public transport** links.

Lyon is just 2 hours from Paris with trains every hour, 3.5 hours from Brussels, 5.5 hours from London or 6.5 hours from Milan.

The main railway stations, Gares de **Lyon-Part-Dieu** and **Lyon-Perrache**, are centrally located.

#### ■ By car

Lyon is at the heart of a comprehensive motorway network linking France's major cities and main European capitals. Ideally located in the heart of Europe, the Lyon Convention Centre is just 1 hour away from Geneva, Switzerland; 3 hours away from Turin, Italy; 4 hours away from Paris, capital city of France; 4.5 hours away from Milan, Italy and 5 hours away from Barcelona, Spain by car.

*Please note that as part of its fight against pollution, Greater Lyon has introduced a 'Zone à Faibles Emissions' (ZFE – Low Emissions Zone) covering Lyon, Villeurbanne and Caluire, as well as Bron: privately owned vehicles with a Crit'Air 4, 5 or 'non-classified' disc, as well as vehicles without a disc, will no longer be allowed to drive and park on roads within the area concerned.*

#### ■ Other

The **Transports en Communs Lyonnais – TCL**, the city's public transport network offers an extensive multi-modal public transport network with 120 bus lines serving over 3000 stops, 4 metro lines, 2 funicular lines and 5 tramway lines, thus making it easy to travel in and around Lyon.

The **Vélo'v**, the local public bike hire service is a convenient way to move around the city, with more than a 1,000 kilometers of cycling path across the Greater Lyon and 428 free dock stations.

### HOW TO REACH THE CONGRESS CENTER

Located in the heart of the Cité Internationale, in the center of the city of Lyon close to the Tête d'Or Park, the CCL-Lyon Convention Centre is ideally located and easily accessible by all means of transport.

- The CCL is just 10 minutes away from the **Lyon Part-Dieu TGV train station** and 15 minutes away from the **Lyon Perrache TGV train station**.
- From the **bus stop Cité internationale** (bus 70 or C1, C2, C4, C5, C26), a 2 minutes walk along the 90 meters distance will take you to the CCL entrance. Use the **TCL website** or mobile app for the best route.
- If you are traveling to the CCL – Lyon Convention Center by car or motorcycle from outside Lyon, we advise you to take the Road Périphérique Nord and exit at **Porte de Saint Clair**. The venue has **3 carparks onsite** in the heart of the Cité Internationale district.
- Should you wish to take a taxi, there are 2 dedicated taxi pick up zones in front of the Lyon Convention Centre: one is next to the main entrance at the foot of the bear statue. The other one can be found close to the main amphitheatre.
- If you are using a **Vélo'v**: 5 bike stations are available throughout the Cité Internationale district, one station is in front of the main entrance of the Lyon Convention Centre and another one is close to the main amphitheater.
